In 2019, we focused on **efficiency** and **accomplishments**. We kicked off our busy season with our **5 Mile Dogtown Trail Run**. The second year ran more smoothly for all involved and it felt like we hit our stride! Hosting a trail run has been a great way to share our mission of promoting the safe and responsible use of the trails on Cape Ann. We look forward to our next one (moved to **December 13th, 2020**).

Cape Ann Trail Stewards partnered with the Town of Rockport and City of the Gloucester to do a city-wide cleanup and informative **Earth Day** event. Collaboration with like minded organizations, cities and towns remains a large part of the work we do.

Our **Trail Steward Program** got an 'official' manual and launch. We now have a dozen trail stewards maintaining trails across Cape Ann. With regular check ins, guidance via printed manual, and our CATS appointed town guides, our Steward program has been a great success.

Our **website** has undergone revisions this year, including the addition of a number of new trail maps and descriptions. Our **Field Guide** (which can be found on our website) has been such a hit we had it reprinted!

Providing **organizational support** and **services** to like minded organizations is another focus area for our group. In 2019, we worked with each town in our work area on trail creation, access and improvement. Some highlights include:
